§ 118-1. Administrative fees.

- A. Municipal lien letter: \$25.
- B. Occupancy permit: \$45. [Amended 5-2-2005 by Ord. No. 1001; 12-4-2006 by Ord. 1017]
- C. NSF check: \$35.
- D. Copy fees: \$0.25 per page. [Amended 2-2-2009 by Ord. No. 1026]

§ 118-2. Police fees and fines.

- A. False alarm occurrences are accumulated and tracked, per structure, on a yearly basis from January 1 to December 31. False alarm fees are assessed on a yearly basis from January 1 to December 31.
- B. Police reports: \$20. [Amended 12-4-2006 by Ord. 1017]
- C. Fingerprints: [Amended 5-2-2005 by Ord. No. 1001]
 - (1) Resident: \$15.
 - (2) Nonresident: \$30. [Amended 12-14-2006 by Ord. No. 1017]
- D. Records check: \$15.
- E. Beginning April 1, 2005, Borough parking tickets: [Amended 2-22-2005 by Ord. No. 1000]

- (1) If payment is received within 72 hours of the issuance of the ticket: \$10.
- (2) If payment is received after 72 hours of the issuance of the ticket: \$20.

F. False alarms¹ : **[Amended 12-4-2006 by Ord. 1017]**

- (1) First occurrence: no charge.
- (2) Second occurrence: \$30 per occurrence.
- (3) Third through seventh occurrence: \$50 per occurrence.
- (4) Eighth or higher occurrence: \$100 per occurrence.

§ 118-3. Peddler's permits fees. ²

For the purposes of this ordinance, a "peddler" is defined as someone who is soliciting door-to-door for a for-profit commercial enterprise.

- A. Per day: \$10 per person.
- B. Per week: \$25 per person.
- C. Per month: \$100 per person.

§ 118-4. Parking fees.

- A. Residential on-street 3:00 a.m. to 5:00 a.m. permit: \$36 per year.
- B. Borough lot permit: \$60 per year.
- C. Nonresident permit: \$120 per year.
- D. Commercial vehicle permit: \$120 per year.
- E. Recreational vehicle permit: \$240 per year.
- F. Overnight guest days: \$15 per each thirty-day increment.³ **[Added 7-21-2008 by Ord. No. 1024]**

§ 118-5. Construction- and zoning-related fees.

- A. Sanitary sewer tap: \$200 per unit.⁴
- B. Street opening: \$175, plus \$1/foot. **[Amended 7-18-2005 by Ord. No. 1005]**

§ 118-6. Building fees.⁶

- A. Residential.
 - (1) New construction: \$40 plus \$0.17 per square foot of gross floor area.
 - (2) Additions: \$40, plus \$0.17 per square foot of gross floor area.
 - (3) Alterations and repairs: 1.25% of construction cost (minimum fee of \$40).
 - (4) Utility and miscellaneous use groups: 1.50% of construction cost (minimum fee of \$40).
- B. Commercial.
 - (1) New construction: \$60, plus \$0.25 per square foot of gross floor area.
 - (2) Additions: \$60, plus \$0.25 per square foot of gross floor area.
 - (3) Alterations: 2.5% of construction cost (minimum fee of \$60).
- C. Demolition.
 - (1) Residential: \$125.
 - (2) Commercial: \$225.
- D. Signs: \$25, plus \$2 per square foot of sign area (minimum fee of \$40).

§ 118-7. Mechanical fees.

Mechanical fees are applicable for air conditioning, furnaces, hot-water heaters, and supply lines to these appliances not applicable for a building permit.

- A. First \$1,000 of installation costs or fraction thereof: \$40.
- B. Each additional \$1,000 or fraction thereof: \$10.
- C. Minimum fee: \$40.

§ 118-8. Miscellaneous fees.

- A. Mulch: \$40 per load.
- B. Amusement device license:⁷ \$125.
- C. Vehicle extrication fee: \$250. **[Added 8-1-2005 by Ord. No. 1003]**
- D. Plumbing certificate: \$2. **[Added 8-1-2005 by Ord. No. 1003]**
- E. Basic service sewer rate: \$4.70 per 1,000 gallons of water used.⁸ **[Added 8-1-2005 by Ord. No. 1003; amended 9-5-2006 by Ord. No. 1014; 7-9-2011 by Ord. No. 1036]**
- F. Permit fee for cutting the curb, constructing a sidewalk across a driveway, or altering or changing either of them: \$1. **[Added 8-1-2005 by Ord. No. 1003]**
- G. Additional recycling bin: \$10 per bin. **[Added 8-1-2005 by Ord. No. 1003]**
- H. On-street dumpster permit: \$25. **[Added 5-2-2005 by Ord. No. 1001]**
- I. Liquor license application: \$500. **[Added 5-2-2005 by Ord. No. 1001]**
- J. Video production: \$250. **[Added 12-4-2006 by Ord. 1017]**
