2023 Budget Highlights

The general fund budget represents an important directive for the operations of the Borough for the coming year. Borough staff and council members created the 2023 budget with a focus on meeting expenses without raising taxes. Economic uncertainty coupled with rising inflation and materials costs heavily influenced spending decisions. The approved and balanced general fund budget for 2023 is \$4,028,787. This is an increase of 10.2 % (\$375,413) from the approved 2022 budget of \$3,653,374.

A draft 2023 budget was prepared by the borough manager and reviewed by the general government committee throughout September and October of 2022. A budget meeting was held on November 12, 2022 where borough council reviewed several versions of the 2023 budget. Council approved a balanced budget that held property taxes steady at 7.185 mills on December 5, 2022. The 2023 property tax rate remains 7.185 mills, unchanged since 2016. Property taxes are the largest revenue source (47%) for the Borough and are projected to generate \$1,891,505 in 2023. One mill generates approximately \$261,000 in revenue. On average, a home owner will pay about \$1,193 in property taxes to the borough and \$4,484 to the school district.

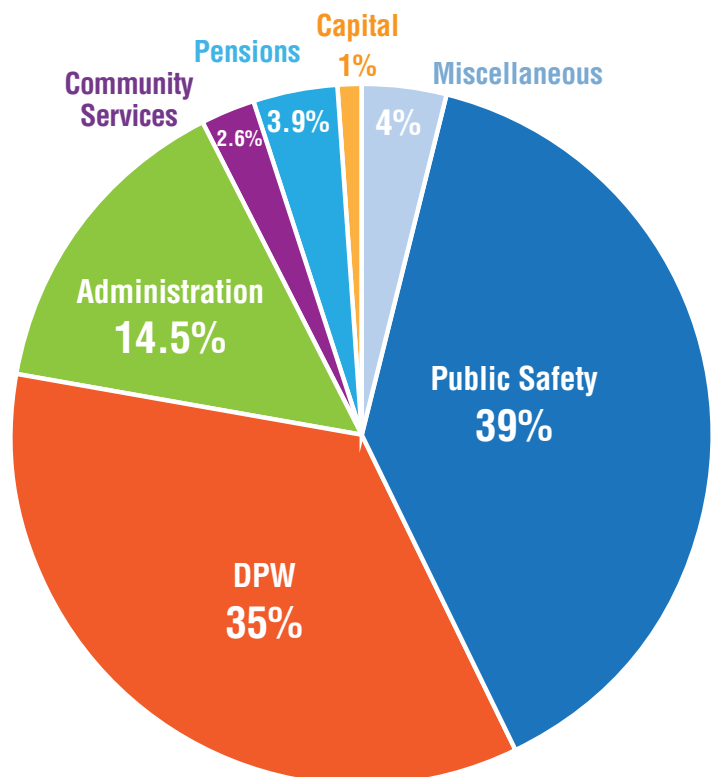
The second largest revenue source is the Earned Income Tax. This is a 1% tax on gross wages, net profits and other income earned by Borough residents. The 1% tax is split between the Borough (0.5%) and the School District (0.5%). Current and delinquent earned income tax revenue in 2023 is expected to be \$785,000. Earned income tax revenue represents approximately 19% of the borough's revenue. Fees, state

allocations, grants and other taxes constitute the remaining 34% of the borough's anticipated 2023 revenue.

The borough was forced to make several difficult spending decisions in this budget. Increases in health care costs, liability and workers compensation premiums, and raw materials reduced expenditures in other categories. For example, Borough Council decided against replacing a police vehicle in 2023 because the price jumped from \$46,000 in 2022 to \$55,000 in 2023. But, council fulfilled the CC Mellor Library's request for additional funding in 2023; committing

Winter Weather Reminders

to a \$44,000 donation for operations. Donations to the library have steadily risen from \$38,500 in 2020 and account for 1% of all borough expenditures. Other capital items were reduced or delayed altogether to keep spending in line with expected revenues.

The \$1.43 million police department accounts for 35% of total general fund expenditures. The 2023 budget covers wages and benefits for nine full time police officers and police chief. Just over 1% of the budget is discretionary and those extra funds were applied towards additional officer trainings, new officer testing and hiring needs, and buying new first aid gear.

The \$1 million public works department accounts for 24% of total general fund expenditures. The 2023 allocation includes the aforementioned \$400,000 road paving program and wages and benefits for four employees. The borough will purchase 300 tons of rock salt under a statewide cooperative purchasing contract totaling \$27,000. Council also approved a capital transfer of \$30,00 for future equipment replacement. Finally, council allocated \$25,000 in funds for the implementation of a salt brine system for snow and ice control.

The borough's general fund pension and debt obligations in 2023 amount to \$273,600. The Borough is required by state law to contribute \$159,000 to its police and non-uniform pensions to maintain their long-term viability. The remaining \$114,600 is for repayment of a \$1 million road paving loan which will be satisfied in 2024.

The borough owes \$74,000 on 20-year loans taken out in 2005 to fund major sanitary sewer repairs on Race Street. Annual payments of \$28,800 against these loans are made from the borough's \$1.6 million sewer fund. The primary source of revenue for this fund is the surcharge levied by the borough on every 1,000 gallons of water a resident consumes. The revenue raised by this surcharge can only be applied to expenses incurred in the operation and maintenance of the borough's sanitary sewer system. Borough Council approved increasing the 2021 surcharge from \$4.70 to \$5.70 per 1,000 gallons used to offset maintenance costs and system upgrades.

Overall, the 2023 budget addresses the borough's immediate and near-term needs without raising taxes. It's clear that rising costs have reduced spending flexibility and forced some belt-tightening, but no significant cuts were needed to balance the budget.

SPOTLIGHT ON LOCAL BUSINESS

Cornelius Boots

Resident and musician Cornelius Boots is a certified Dai Shihan (grandmaster) of Zen shakuhachi and an award-winning composer. A lifelong woodwind performance innovator, Boots also earned three music degrees from the renowned Jacobs School of Music at Indiana University and has released over 12 albums as a leader and written over 100 compositions for under-represented instruments (bass clarinet and shakuhachi). A finalist in the 2018 World Shakuhachi Competition, he was also a featured performer or presenter that same year at the World Bamboo Congress (Xalapa), the World Shakuhachi Festival (London) and the Sony E3 Conference (LA).

A recent transplant to the neighborhood, he moved here from the San Francisco Bay area. He spent the last twenty years on the west coast, but with the rising cost of living and increasing risk of wild-fires there, he decided to find a safe and welcoming place to call home. He also longed for four distinct seasons like he experienced where he grew up, near Philadelphia. Mr. Boots decided on Edgewood after he explored the area and discovered some of the nearby amenities. The things he likes best about living here are the friendly people and the proximity to Regent Square, with its restaurants and his favorite coffee shop, plus Frick Park. He also appreciates the convenience of concerts at the Presbyterian Church.

Saturday, April 1 (rain date, Sunday, April 2)

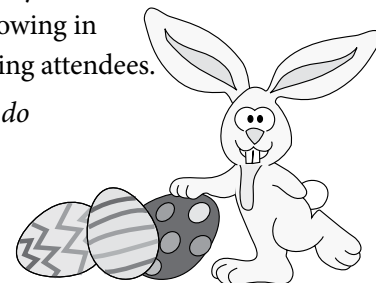

2023 Starter Plants Sale for Veggies and Herbs Begins Now!

From our grower:

It's time to choose and place your 2023 herb and veggie plants order, fellow gardeners! Hope you had a productive 2022 growing season. All plants will be of good size to transplant into your garden. Thank you again for pre-paying, to cover up-front costs. **The deadline for ordering and pre-paying online is February 13, 2023.** This enables early seed ordering, ensuring you get what you want!

Here's how to choose and order plants:

1. First, use this list and descriptions of **2023 Herbs & Veggies** to inform your plant choices, as before.
2. Begin ordering and paying right now, January 29 through February 13 at: ksandorfgallery.com/herb-and-veggie-starter-plants. No order forms to fill out and return! Easier for all of us.
3. You'll pick up your plants on one Saturday in mid-May at Koenig Field. The following day, Sunday, is the rain day (only if rain is heavy). The pickup date and times are TBD and we'll let you know.
4. After February 13 (see #2 above), seeds will be ordered. There will be extra plants available after that, but the folks who order and pay by February 13 will get first choice.
5. Plant varieties will be removed from their web page asap if/when capacity is reached.
6. Some plants, mostly tomatoes, have not been as popular as others, but some folks order them every year. Using seeds already on hand, these varieties are listed as LIMITED SUPPLY on the last page of **2023 Herbs & Veggies**, and in the drop down menu's plant names on the web page. When these plant orders reach capacity they will also be removed from their web page.

It's the best time of year to plan your garden! This grower is happy to help you.

Zen Shakuhachi Concert & Meditation - 深禅 尺八

Edgewood resident and certified Grandmaster (dai shihan) Cornelius Boots presents the living tradition of shakuhachi—the rare bamboo flute from ancient Japanese Buddhism. The old monastic repertoire shares the program with new, robust solo compositions and arrangements that slowly emerged as the bamboo was integrated into Boots' original training as a creative jazz wood-winder in the lineage of John Coltrane, Eric Dolphy and Rahsaan Roland Kirk. Meditation, music and nature form the roots of this earthy and ephemeral performing art. Natural bore (jinashi) and larger, low-pitched flutes (bass or alto) flutes are featured on this program: they provide a strong connection—for both the player and the listener—to a deeper, almost primeval past: like echoes from the ancient days of the Earth.

Tee-ball

Tee-ball is for girls and boys ages 4-7, with the addition this year of 4 year-olds. Children should be 4 as of June 1.

Also new this year, if registration numbers allow, we are planning to break participants into two divisions:

Division 1 (4/5 year-olds), and Division 2 (6/7 year-olds). Division 1 will focus on player participation and learning basic skills. Each child gets to bat and field each inning, with all games being played from the Tee. Division 2 will build on the basics, and introduce more team-based skills, with position play, and counting of outs (no strike-outs). Depending on progression of the group, Division 2 has the potential to move to coach-pitch later in the season.

This sport will meet twice weekly; days and times are TBD. Cleats may be worn, but are not necessary. Shirts and caps will be provided.

Softball

Softball is open to girls and boys ages 7-13. This sport meets twice each week. There is typically a "spring training" during the first 2 weeks, with an additional practice. EDGEWOOD RECYCLES

Republic Services asks that all recyclables be empty, clean, and dry. This means that all containers must be completely free of food, grease, or liquids. When in doubt, throw it out.

Edgewood residents can recycle flattened cardboard, paper, newsprint and mail; cleaned metal and aluminum cans; cleaned #1 & #2 plastic bottles, jugs, and clamshells. Clamshells for produce or fruits made of #1 or #2 plastic that can be rinsed clean can be recycled. Small containers (travel sized) can be recycled but must be clean. Please discard ALL containers that cannot be rinsed clean. A dirty container can contaminate the recycling stream rendering it unrecyclable.

Republic Services has stationed a large blue dumpster in the parking lot behind the Edgewood Borough building (2 Race Street), for items to be dropped off at residents' convenience. This bin is for GLASS COLLECTION ONLY and is located next to the paper collection bins.

All items should be placed loose in a recycling bin. Do not place any recyclables in plastic bags! Bags of recyclables will be treated as refuse and land-filled. Please keep all plastic bags out of the recycling stream.

Plastics #3-#7 are not recyclable and should be placed in the trash. Many common items made of plastic or metal including children's toys, household appliances and furnishings, and flatware should be discarded as trash. More examples include clothes hangers, plastic bags and wrappers, scrap metal and aluminum foil. These items are not recyclable and clog the sorting machines.

Take out containers are not recyclable. Any container made of Styrofoam, laminated paper, or plastic, even if it's #1 or #2, contaminated with food waste should be discarded as trash. Cardboard pizza boxes are not recyclable. Drinking straws, stirrers, and plastic utensils are not recyclable.

Household Hazardous Waste (HHW) and E-Waste collections can be scheduled for pickup by calling Republic Services customer service at 800-464-2120. Appointments for HHW and E-Waste pickups must be scheduled; these items will not be collected with residential collection. Questions about service, bulk items, or container delivery should also be directed to the customer service line.

Local Discussion on Gun Violence

Members of the Edgewood community and surrounding neighborhoods were brought together by Edgewood Councilmember Bhavini Patel and CeaseFire PA at the Edgewood Presbyterian Church for a discussion on gun violence.

The goal was to provide an open space and bring people together to foster grassroots change on an issue that is impacting everyone in our region.

"There's a lot of trauma that can be associated with being so proximate to gun violence," said Bhavini Patel, an Edgewood Borough Councilmember. "I think that it's important to have an intersectional group of people coming together to discuss the increase that we're seeing and respond in a way that addresses the root causes of violence."

Panelists for the discussion included Allan Willinger with the Edgewood Neighbors for Gun Safety, Josh Fleitman with CeaseFirePA, Linda Lennon with H.O.O.P Alliance, Dr. Raquel Forsythe who is the Director of Trauma with UPMC, Ben Reynolds who is the Chief Advanced Practice Officer at UPMC, and Pastor Janet Hellner-Burris with the Wilkinsburg Sanctuary Project for Peace.

Mayor Ryan O'Donnell, who has been a proactive advocate for local government taking action on gun violence prevention, was in attendance as well as Sergeant Fred Livingston.

Councilmember Patel will be organizing a *Stop the Bleed* training for community members in Edgewood and neighboring areas. Information will be made available as soon as details are finalized.

Woodland Hills student artwork to be featured at Carnegie Museum of Art

Student artists in the Woodland Hills School District will have their works displayed at the Carnegie Museum of Art as part of the museum's prestigious International Art Show in the spring of 2023. The artwork will be on display for a two-week period beginning at some point after April 24, 2023. The exact dates are still to be determined.

"This is a pretty wild situation and the students are pretty excited," high school art teacher Ms. Saige Wagerman said. "This international show only happens every four years. It features artists from around the world. And it's an incredibly famous show that draws people in from all over the country. The fact that they get to have their art during the this show in the same building is pretty wild."

The artwork will be on display in the museum's Hall of Architecture. Submissions from students at all grade levels can be art that has already been created or art that is completed over the next few months. The works can be done in any medium, and do not have to be done as part of a class project.

Students can share their completed artworks with Ms. Wagerman, who will help arrange for the final selection process. While it's unknown at this stage how many pieces of art will be able to be included as part of the showcase, the hope is that it will feature about 30 student submissions per art teacher in the district, or about 175-200 pieces of art.

More information, including specific dates of the exhibition and how to gain admission, will be shared closer to the exhibition in the spring.

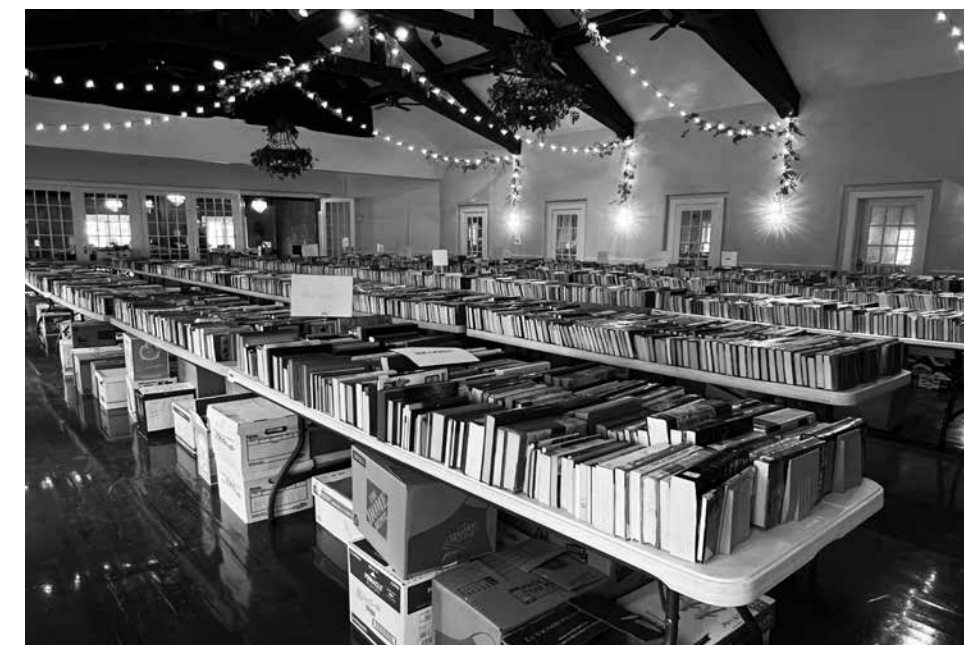

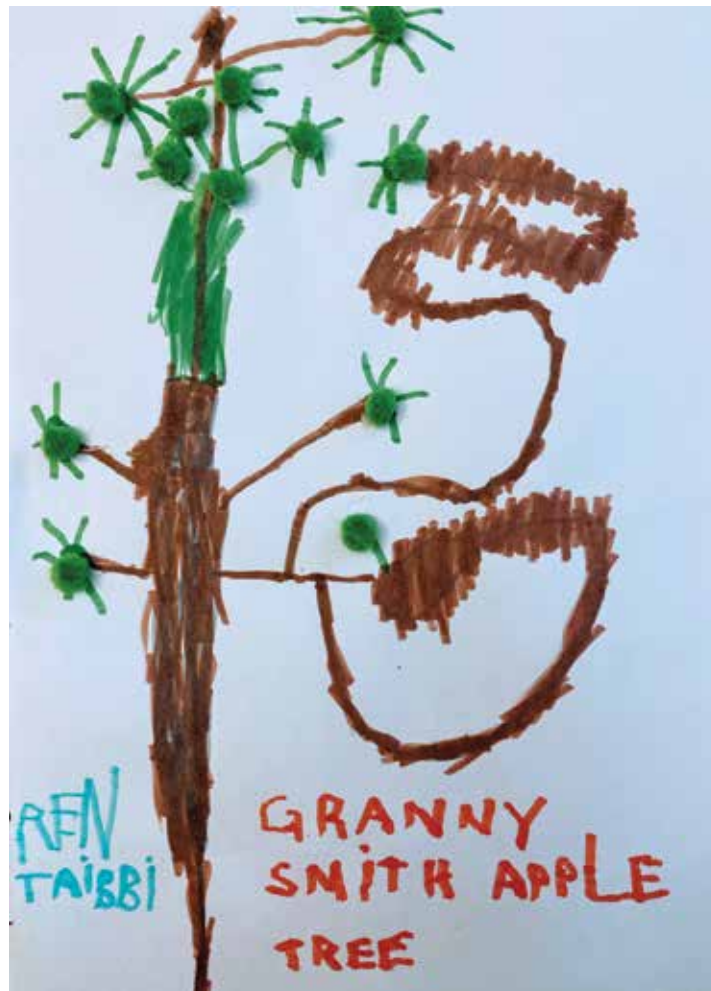
