Motion to authorize payment of bills - Ms. Gleba

I move to authorize the payment of bills, for goods and services received by the Borough, having been reviewed and approved by the General Government Committee, from the General Fund in the amount of \$56,768.10 and from the Sewer Fund in the amount of \$11,883.74, for a total of \$68,651.84.

CIVIL SERVICE TESTS FOR POLICE OFFICERS AND SERGEANTS PROMOTION – Mr. Fuller

I move to hire Bill Gamble, Police/Fire Testing Consultant, to conduct the written testing for both the Entry Level Police Officer and the Police Promotional Test for the position of Sergeant, subject to review by the Civil Service Commission. The written test used for Entry Level Police Officer will be the I/O Solutions Public Safety Testing/ Entry Level Test. The Internal Personnel Management Association written test will be used for the position of Sergeant.

CIVIL SERVICE TESTING - POLICE OFFICER - Mr. Fuller

I move to authorize the Civil Service Commission to conduct testing for the position of Entry Level Patrol Officer and to provide the Borough with a list of eligible candidates.

CIVIL SERVICE TESTING - SERGEANTS - Mr. Fuller

I move to authorize the Civil Service Commission to conduct promotional testing for the position of Sergeant and to provide the Borough with a list of eligible candidates.

PART-TIME RECREATION COORDINATOR - Mr. Wainright

I move to hire Meghan Slavic as the part-time Recreation Coordinator for the Borough. She will be paid \$9.00 per hour.

PART-TIME POLICE OFFICERS - Mr. Fuller

I move to hire Joseph Tomko and Matthew Bissell as part-time Police Officers contingent on them passing a physical, psychological test and a background investigation. Starting rate of pay is \$13.00 per hour.
