BOROUGH OF EDGEWOOD MINUTES OF THE MEETING OF COUNCIL HELD MONDAY, SEPTEMBER 21, 2009

Vice President McDonald called the Meeting of the Council of the Borough of Edgewood to order on Monday, September 21, 2009 at 7:33 PM in the Municipal Building.

Borough Manager Warren Cecconi called the roll and the following responded: Ms. McDonald, Mr. Shultz, Mr. Reynolds, Mr. Cook, Mr. Hellett.

Ms. Schaefer and Mr. Fuller were absent.

Mayor Davin was not at the meeting, but was in the Borough. Borough Solicitor Barry and Junior Councilperson Horner were also present.

The Pledge of Allegiance was recited.

ITEMS FROM THE FLOOR

Mr. O'Nan of Mifflin Avenue, a writer and formerly from Connecticut, shared an impassioned speech about support for the C. C. Mellor Library and Community House. He closed his message by asking Council to please see the Library as an investment for the future with immediate and far reaching rewards.

Ms. McDonald thanked Mr. O'Nan for his comments and stated that the Borough will continue to support the Library.

Mr. Hellett stated that fifty percent (50%) of the elected officials have been on the Library Board and share Mr. O'Nan's passion.

Next, Mr. Evashavik of Locust Street spoke on behalf of his daughter, a student at Oakland Catholic School. For a school project, Council was asked to take a picture with Ms. Evashavik.

Ms. McDonald, liaison for the Junior Councilperson, encouraged the students in attendance.

Mr. Evashavik thanked Council for keeping Edgewood in the great shape that is in.

MULTI-MUNICIPAL COMPREHENSIVE PLAN ADOPTION RESOLUTION

WHEREAS, the Pennsylvania Municipalities Planning Code (Act of 1968, P.L. 805, No. 247, as reenacted and amended) (MPC) empowers boroughs, individually or jointly, to plan for their development and govern the same by zoning, subdivision and land development ordinances; and

WHEREAS, the municipalities of Edgewood Borough, Rankin Borough, and Swissvale Borough, Allegheny County, can each be characterized as first-ring or first-tier suburbs that are all situated along Braddock Avenue and share common issues; and

WHEREAS, the three neighboring boroughs have joined together for the purpose of mutual cooperation through multi-municipal planning; and

WHEREAS, a joint steering committee comprised of leadership of each of the three boroughs was formed to oversee the development of the multi-municipal comprehensive plan; and

WHEREAS, the steering committee met monthly during the planning process to develop the multi-municipal comprehensive plan; and

WHEREAS, the steering committee undertook a public involvement process by conducting five (5) public meetings and a questionnaire; and

WHEREAS, the multi-municipal comprehensive plan identifies key priorities for land use, economic development and revitalization, historic preservation, community services and infrastructure, transportation, and housing per the Pennsylvania Municipalities Planning Code (MPC); and

WHEREAS, Allegheny County, surrounding municipalities, and the Woodland Hills School District have reviewed or been given the opportunity to review the multi-municipal plan per the MPC; and

WHEREAS, said plan has been subject of a public hearing per the MPC.

WHEREAS, that the undersigned do hereby adopt the multi-municipal comprehensive plan titled "Partnerships" as the official comprehensive plan of the Borough of Edgewood.

BOROUGH MANAGER'S REPORT

Mr. Cecconi expressed his desire to speak with the General Government Committee regarding the streamlining of the parking program.

Mr. Cecconi, Chief Payne and Mr. Guerriero met regarding the G-20 Summit and Mr. Cecconi noted that the Chief has controls in place. He stated that the problem will be the traffic.

Mr. O'Connor is working with Mr. Cecconi to get National Flood Insurance Program help.

Mr. Cecconi said that he and Ms. Schaefer met with the Pittsburgh Water and Sewer Authority and Mr. Schombert.

DISCUSSION: Ms. McDonald said that she, Ms. Schaefer and Mr. Cook had a positive meeting with the residents of Greendale Avenue. She noted that Mr. Cecconi presented a detailed timeline with steps of what has been done to minimize the frustration.

Regarding Pittsburgh Water and Sewer Authority, Mr. Barry gave historical information, stating that the Borough reached tentative agreement with them, stating that the issue was not with the authority, but with the city of Pittsburgh.

Everything, according to Mr. Barry, was approved by PWSA and then they reversed their feelings, saying they were not going to approve abandonment of the line. He then gave a brief history of how this line got to be where it is currently.

Continuing with his report, Manager Cecconi informed Council that he and Ms. Lewis met with Mr. Noel who monitors the Borough's website in an effort to get some of our routinely-used forms online.

M-9 Mr. Cook offered Resolution 2009-30 and asked for its immediate adoption. Second by Mr. Reynolds.

EDGEWOOD BOROUGH RESOLUTION 2009-30

WHEREAS, this fall, on September 26th, the Western Pennsylvania School for the Deaf (WPSD) will celebrate its 140th Anniversary and 125th year on the Edgewood campus.

WHEREAS, the story begins in the summer of 1868 at the Third United Presbyterian Church. A young African-American boy named Henry Bell showed up at the Mission Sabbath School class. He was bright and active, but no one knew how to communicate with him. He was deaf; and

WHEREAS, the needs of this boy served as the catalyst that resulted in the establishment of the first day school for deaf children in the United States. The school opened on September 4, 1869, with nine deaf pupils at the First Ward Public School in Pittsburgh. It would be known as the Western Pennsylvania Institution for the Deaf and Dumb. Ten years later, in 1879, there were 98 deaf children from 17 counties attending WPID and when school started at the Edgewood location on October 4, 1884 there were 120 pupils enrolled; and

WHEREAS, today, WPSD is still a tuition-free school with high academic expectations. Over 250 children from birth through twelfth grade are served through the campus in Edgewood. And, beginning with the 2009-2010 school year, WPSD will administer the education and extra-curricular programs for the Scranton School for Deaf and Hard-of-Hearing Children (SSDHHC) with over 90 children enrolled from preschool through twelfth grade. WPSD and SSDHHC offer an all inclusive language environment. communications needs are met on an individual basis with the goal of fluency in both English and American Sign Language; and

WHEREAS, one thing has remained unchanged since 1869, and that is the school's commitment to educational excellence in addition to the physical and social wellbeing of deaf and hard-of-hearing children. From the very beginning the mission of the school has been to offer these children every opportunity to succeed in life; and

WHEREAS, for 140 years, WPSD has continued to grow and improve, thriving on the diversity of our students and recognizing that all children are special in their own way. It is our responsibility as educators to continue to raise the standards and expectations we have for our children. Each year, student achievement improves and we continue to seek better ways to provide teaching and learning to our students; and

WHEREAS, WPSD/SSDHHC is many things to many people. We honor the school, its students, staff, parents and alumni on their 140th anniversary and their continued dedication and success with Pennsylvania's deaf and hard of hearing children; and

NOW THEREFORE the Council of Edgewood Borough proclaims September 26, 2009 as **WESTERN PENNSYLVANIA SCHOOL FOR THE DEAF DAY** in the Borough of Edgewood.
