MONDAY, JANUARY 11, 2010

The Pledge of Allegiance was recited.

**ITEMS FROM THE FLOOR**

Dr. Wallace of 326 Maple Avenue welcomed the new Council people and thanked them for their service to the community. He also thanked Mayor Davin for making sure everything is in order. Dr. Wallace again addressed the two mill increase being used to cover the current budget.

Ms. Schaefer and Mr. Hellett gave an overview of the budgeting process and Ms. Waldock and Ms. Gleba shared their initial experience in working with the budget.

**M-1 Ms. Gleba made a motion to override the Mayor's veto by reaffirming the adoption of Ordinance 1030 setting the Real Estate tax rate for 2010 at 8.661 mills. Second by Mr. Hellett.**

Upon roll call vote, the following was recorded: Mr. Hellett, Ms. Waldock Mr. Wilson, Ms. Schaefer voted yes. Mr. Bright, Mr. Bowers, Ms. Gleba voted no. **MOTION FAILED.**

**M-2 Ms. Gleba moved to reopen the 2010 budget. Second by Mr. Wilson.**
