MOTION TO AUTHORIZE PAYMENT OF BILLS – MR. LOVE

MOTIONS TO AMEND CIVIL SERVICE RULES – MR. ELLIS

I move to revise Section 4.3, Paragraph (h), line (1) to read “three (3) years as Patrol Officer,” meaning that an external applicant for appointment to a Sergeants position shall have at least three (3) years of full-time law enforcement experience to be eligible for appointment.

I move to revise Section 4.4, Paragraph (c), line (1) to read “four years as a patrol officer. Experience shall be considered any combination of time the applicant served as a sworn police officer at any agency, with a minimum of one year of full time service with the Edgewood Borough Police Department.
